<p><b>26 June 2016</b>  <b>Sunday</b></p> <p><b>Saint Peterburg</b></p>	<p><b>Saint Peterburg</b>, the luxurious “northern capital” of the former Russian Empire, with its magnificent palaces, golden church domes, spacious avenues and streets filled with glorious monuments, leaves no one unimpressed.</p> <p>Saint Petersburg is particularly popular with tourists during the period of the <b>White Night</b>. For those participating in the event, this will be an added bonus as the cultural programme in this beautiful city continues all the way until midnight.</p> <p><i>The phenomenon of the White Night, or the Midnight sun, is a period of time when the sun does not set at the latitudes above the Arctic Circle. At the latitudes below the Arctic Circle, the sun does not go much below the horizon and this prevents the night from becoming very dark. You can enjoy rare solitude walking the deserted streets with the classical architecture intensified by this unreal light which creates a fantastic atmosphere.</i></p> <p><i>The White Night lasts more than 50 days, from May 25th until July 16th, but its characteristics are most visible close to June 21st - the date of the summer solstice. What makes the White Night unique in Saint Petersburg is the combination of the intrinsic beauty of the city and this almost supernatural lighting which magnifies the classic elegance of the buildings and the palaces, the channels and bridges, the statutes and churches. Every year, this magic attracts visitors from the whole world and the period from the mid-May to the mid-July is considered the high season.</i></p> <p><b>All visits</b> are accompanied by an English-speaking guide.</p> <p><b>09:00-11:00</b> A guided tour across Saint Petersburg which will allow you to discover the greatest monuments of this historic capital of Russia and popular sightseeing destinations such as the Saint Isaac Cathedral, the cruiser Aurora and the Fortress of Peter and Paul. This city, founded by Peter the Great, exemplifies the elegance and cultural heritage of Russia.</p> <p><b>11:00-13:00</b> A visit to the Hermitage Museum, which holds among other things an excellent collection of Russian art.</p>

<p><b>27 June 2016</b> <b>Monday</b> <b>Saint Petersburg</b></p>	<p><b>09:00 – registration</b></p> <p><b>Overview:</b> 15 sessions (divided as follows: 7,5 hours in Saint Petersburg, 27 juin 2016 and 7,5 hours in Moscow, 29 Juin 2016) with hundreds of Russian lawyers who are looking for foreign lawyers to represent their clients abroad, especially in the fields of <i>investments law, commercial law, international public law, human rights, immigration law, sanctions regulation and legal advice, real estate transactions, energy and natural resources law, corporate law, international law, EU law, tax law and customs law, family law, international arbitration</i> and other fields of law where fruitful legal cooperation is possible.</p> <p>During 7 sessions, the delegation of 15 foreign lawyers meets about 100 Saint Petersburg lawyers who are interested in collaboration with foreign colleguagues. Each session typically consists of 30 lawyers (15 foreign lawyers and 15 St. Petersburg lawyers) sitting around three tables (10 participants and an interpreter at each table). It takes 15 minutes to deal with the essentials at each table, with simultaneous interpretation into Russian (45 minutes for 3 tables). The purpose of each session is for Russian lawyers to find partners to help represent their clients abroad. After each period of 15 minutes the participants change tables, until they have completed the circuit and finish the session.</p> <p><b>The schedule:</b></p> <p><b>09:15-10:00</b> <u>1st session</u> (with 15 Russian lawyers)  <b>10:00-10:15</b> Coffee break to provide a chance for a less formal discussion with lawyers with whom you are interested in collaborating (The interpreters will be present during all the coffee breaks in order to help with the necessary negotiations).  <b>10:15-11:00</b> <u>2nd session</u> (with 15 Russian lawyers)  <b>11:00-11:15</b> Coffee break  <b>11:15-12:00</b> <u>3rd session</u> (with 15 Russian lawyers)  <b>12:00-12:15</b> Coffee break  <b>12:15-13:00</b> <u>4th session</u> (with 15 Russian lawyers)  <b>13:00-14:00</b> Mid-day break with a buffet featuring Russian and European specialities</p> <p><b>14:00-14:45</b> <u>5th session</u> (with 15 Russian lawyers)  <b>14:45-15:00</b> Coffee break.  <b>15:00-15:45</b> <u>6th session</u> (with 15 Russian lawyers)  <b>15:45-16:00</b> Coffee break.  <b>16:00-18:00</b> Speeches by a Representative of the Moscow City Bar (with simultaneous interpretation) and the Reception.</p> <p><b>The benefits:</b></p> <ul style="list-style-type: none"> <li>- Network with the Presidents of the Moscow City Bar and Saint Petersburg City Bar;</li> <li>- 100 Saint Petersburg lawyers interested in cooperation with foreign partners;</li> <li>- Publication of a directory with information and contact data of the foreign lawyers who participate in the event. 
### REGISTRATION AND PAYMENT

## The registration fee includes:
